Carers UK's new report Heading for Crisis: caught between caring and rising costs, focuses on the impact of the cost of living crisis on unpaid carers, in terms of their finances as well as their health and wellbeing.

The research is based on a survey of over 13,000 unpaid carers, who completed our State of Caring survey 2022. The report finds that:

- 1 in 6 carers are in debt as a result of their caring role, increasing to 2 in 5 for carers in receipt of Carer's Allowance.
- The proportion of carers unable to afford their utility bills has more than doubled since last year to 14%.
- Carers in receipt of Carer's Allowance are more likely to be cutting back on food and heating.
- Nearly all carers who are struggling to make ends meet (93%) agreed that the increase in the cost of living was having a negative impact on their mental and physical health.

October 2022 Latest update on the Ofsted inspection



Following the inspection of the district's Special Educational Needs and/or Disabilities (SEND) services that was carried out by Ofsted and the Care Quality Commission (CQC) in March this year, Bradford Council and the West Yorkshire Integrated Care Board (ICB) were asked to produce a written statement of action outlining how it would make improvements to five areas of service where there were significant weaknesses in local practice.

The statement of action has explained how the following areas would be improved:

• Poor communication between stakeholders across education, health and care.



- The variable quality of Education, Health and Care Plans (EHCP), including plans which do not fully describe the provision that children and young people with SEND need.
- The inconsistent delivery of the O to 19 health visiting, school nursing and specialist nursing services.
- Children and young people wait too long for assessments, treatment and diagnosis. There is insufficient support for children and young people with SEND who are waiting for provision, services, diagnosis or equipment.
- Education, health and care services do not work together well. The arrangements for joint commissioning are underdeveloped

October 2022 Sunflower Lanyards - a parent's experience

The airport can be an uncomfortable place for some of our children. Sensory wise it's loud, warm, bright, busy So I just wanted to share our recent experience. We were lucky enough to go abroad in the summer and I had booked special assistance for my son as I usually do. You go to the special assistance desk and they sort you out from there. This allows us to move quickly through check in and security and board the plane first.



It's been a game changer really. But, this experience was different. My son never normally wears a sunflower lanyard but he does in the airport. This time, as soon as the Jet2 staff (I can't comment on any other airline as we will only fly Jet2) saw the lanyard they came over to us and asked what we needed. We were straight to the front to check our cases in and a lovely man took us to the front of the security queue. We were then shown to a special assistance area where we could wait for our flight. It had USB charging ports (perfect for phones and Switch) to keep young man busy. Just before our gate was announced a member of staff came and found us and took us to the gate and we boarded first. This was the same at the other end when we were flying home too. It just goes to show how far sunflower lanyard recognition has come. Even though I had booked special assistance, it wouldn't have mattered if I hadn't really. If you are flying you can pick up a lanyard at the special assistance desk in the airport or at customer services in a lot of supermarkets. Hidden disability understanding matters!

My kids enjoy the play area (youngest especially) and the farm and bird garden (especially the eldest) so there's something for everyone. The walk through the woods is lovely especially this time of year but it can be quite a walk and my youngest especially complained about this. The house is really interesting and we went for the first time inside it. There's a café area which is nice, shop and ice cream hut."

All local authorities must publish a Local Offer, setting out in one place information about provision they expect to be available across education, health and social care for children and young people in their area who have Special Educational Needs (SEN) or are disabled, including those who do not have Education, Health and Care (EHC) plans.

The Local Offer has two key purposes:

- to provide clear, comprehensive, accessible and up-to-date information about the available provision and how to access it; and
- to make provision more responsive to local needs and aspirations by directly involving disabled children and those with SEN and their parents and carers, and disabled young people and those with SEN, and service providers in its development and review.'
