








2022 survey – Yes 57% No 23%






Why doesn't your EHCP meet your child's needs?

- 66 parents responded to this question
- Top 12 codes shown
- Reasons include:
 - EHCP not updated these parents reported not having an annual review
 - Lack of quality
 - EHCP was good but not being delivered
 - School could not deliver all of EHCP
 - Important information not included in the EHCP









New question this survey 165 parents responded to this question Has the EHCP annual review been completed on time?



2022 survey - Yes 47% No 36% Not sure 17%





> EBSA should be acknowledged. My child was not able to attend school and we were basically told to find somewhere else. A better support plan would have helped my child feel able to attend


